News from Sri Lanka

ST ANTHONY'S BOYS' HOME, HEWADIWELA

In July 2007 we took over management of St Anthony's Boys' Home which is owned by the Catholic Church. The Home, set on a property of five acres, consists of several buildings. Many of the buildings were in need of urgent repair and much work had to be done to get the property ready to house children. We spent over \$5,000 AUD to get the buildings and grounds up to an acceptable standard.

Our first child is a seven year old boy named Siva Kumar (pictured). Initially he was very shy and scared in his new surrounds, but he quickly settled in, attends school regularly and you can tell by his grin that things are going well.

We have seen the significant difference we have made to Siva Kumar's life in the past few months and eagerly look forward to helping many more children in the near future.

AGRICULTURAL TRAINING PROJECT, BALANGODA

The 9acre property at Balangoda is being used as an Agricultural Training Project. The land was acquired in August 2006 and much work has been done. They have cleared the undergrowth, installed dams and wells, planted a crop of citrus trees and have plans to grow lemongrass on the property. We hope to distill the oil from the lemongrass with the aim of involving the local farmers and giving them an alternative income.


Opening of St Anthony's Boys' Home - 4th July 2008
